OFFICIAL RULES

1. SPONSOR

2. ELIGIBILITY

4. HOW TO ENTER

During the Sweepstakes Period, eligible participants may enter by signing up for the Waterfront Wanderer pass hosted by Bandwango via Baltimore.org. Limit one (1) entry per person. Entries generated by automated means or exceeding the entry limit will be void.

5. WINNER SELECTION

On or about July 6, 2026, Sponsor will conduct a random drawing from all eligible entries received. Odds of winning depend on the number of eligible entries received.

7. WINNER NOTIFICATION

The potential winner will be notified by email within approximately 48 hours of the drawing. The potential winner must respond within 72 hours to claim the prize. Failure to respond within the required timeframe may result in disqualification and selection of an alternate winner.

The winner may be required to complete and return an Affidavit of Eligibility, Liability/Publicity Release, and any required tax documentation.
